Promoting Interoperability Program

The Promoting Interoperability program did receive a few proposed changes to the program.

PI Program -2023-

Requirement Changes:

- You are now required to submit of the Query of Prescription Drug Monitoring Program (PDMP) measure.
- In addition to submitting the measures for the Public Health and Clinical Data Exchange Objectives, you are required to submit the level of active engagement you have.

PI Program -2023-

Measure Changes:

- There are 2 new eCQMs available (the same ones added to the IQR program).
- There is a new measure is available for the Health Information Exchange Objective – an optional alternative to the 3 existing measures.
- There is a new measure available for the Clinical Data Exchange Objective.
- The number of active engagement options has been reduced from 3 to 2 for the Public Health and Clinical data Exchange Objectives.

PI Program -2023-

Certain PI data will be published on Care Compare.

PI Program -2023-

Point Changes:

- The Public Health and Clinical Data Exchange Objective increases from 10 to 25 points.
- The Electronic Prescribing Objective increases from 10 to 20 points.
- The Health Information Exchange Objective reduces from 40 to 30 points.
- The Provide Patient Electronic Access reduces from 40 to 25 points.

PI Program -2024-

Requirement Changes

 Your reporting requirements are increased from 4 eCQMs to 6 eCQMs to align with the IQR program changes.

Measure Changes

 There are 2 new eCQMs available (the same ones added to the IQR program).

OTHER NOTES

- CMS has established a brand-new hospital designation. Hospitals may now be designated as a birthing friendly hospital.
- If you attest yes to both questions for the Maternal Morbidity Structural measure in 2022, you will be given that hospital designation. This will be publicly displayed on Care Compare in the fall of 2023.
- CMS intends to update the qualifications (and the name) for this designation in future rulings.
