### Changes to the IQR Program

#### ADDING MEASURES

CMS is proposing to add <u>3 new eCQMs</u> in 2025

### HOSPITAL HARM

Pressure Injury eCQM

- Available 2025
- This is a brand-new measure that assesses the number of patients who suffer a new stage 2, stage 3, stage 4, deep tissue, or unstageable pressure injury.

### HH-AKI

Acute Kidney Injury eCQM

- Available 2025
- This is a brand-new measure that assesses the number of patients who have an Acute Kidney Injury (stage 2 or greater) that occurred during the encounter.

#### EXCESSIVE RADIATION

IP-ExRad

Excessive Radiation Dose or Inadequate Image Quality for Diagnostic Computed Tomography (CT) in Adults eCQM

- Available 2025
- This is a brand-new measure that calculates the percentage of CT scans that either used an excessive radiation dose or have an inadequate image quality relative to the threshold.
   Thresholds are based on what the patient was scanned for.

# COVID-19 VACCINATION AMOUNT HEALTHCARE PERSONNEL

HCP COVID-19 Vaccination

- Reporting Quarter: Q4 2023 and beyond
- Starting October 1, 2023, the COVID-19 vaccination HCP measure will be modified to replace the term "complete vaccination course" with the term "up to date" in the HCP vaccination definition and update the numerator to specify the time frames within which an HCP is considered up to date.

# HYBRID HOSPITAL-WIDE READMISSION AND HYBRID HOSPITAL-WIDE MORTALITY

HWR & HWM

- Reporting Year: July 1, 2024 June 30, 2025
- Starting July 1, 2024, both measures will include Medicare Advantage beneficiaries in addition to the current Fee For Service (FFS) Medicare beneficiaries.

CMS is proposing to remove 3 measures

# HOSPITAL-LEVEL RISK-STANDARDIZED COMPLICATION RATE FOLLOWING ELECTIVE PRIMARY THA/TKA

THA/TKA complication measure

- Reporting Period: April 1, 2025 –
   March 31, 2028/Fiscal Year 2030
- Starting April 1, 2025, CMS is removing this measure from IQR program. It is moving to the Hospital Value-Based Purchasing program beginning with FY 2030.

### MEDICARE SPENDING PER BENEFICIARY (MSPB)

Hospital measure

- Calendar Year 2026/Fiscal Year 2028
- Starting Calendar Year 2026, CMS is removing this measure from IQR program. It is moving to the Hospital Value-Based Purchasing program beginning with FY 2028.

## ELECTIVE DELIVERY PRIOR TO 39 COMPLETED WEEKS GESTATION

- Retired Beginning: 2024
- Starting Calendar Year 2024, CMS is removing the abstracted PC-01 measure from the IQR program because performance is topped out.

### Changes to the Promoting Interoperability Program

#### MAJOR CHANGES

- You must attest "yes" to the SAFER Guides in 2024
- Increasing the reporting period to 180 continuous days in 2025
- There are 3 new eCQMs available in 2025 (the same ones added to the IQR program)

### Changes to the Hospital Value-Based Purchasing (HVBP) Program

#### ADDING SEPSIS

CMS is proposing to add the abstracted Severe Sepsis and Septic Shock: Management Bundle measure to the Hospital Value-Based Purchasing Program starting with Fiscal Year 2026.

### Changes to the Hospital Value-Based Purchasing (HVBP) Program

#### MODIFYING HCAHPS

CMS is modifying several aspects of the HCAHPs survey (FY 2027) including:

- three new web-first modes of survey implementation
- removing the requirement that only the patient can respond
- limiting supplemental items to 12
- requiring hospitals to collect language and provide the Spanish translation
- extending the data collection period from 42 to 49 days

### Changes to the Hospital Value-Based Purchasing (HVBP) Program

#### BONUS POINTS FOR EQUITABLE CARE

Hospitals can receive bonus points in the program for being a top performer who has a higher share of dual eligible (Medicare & Medicaid) patients.
