The Following are IQR Measures Submitted via a Web-Based Tool: The deadline for entering these via HQR Portal is **May 15, 2023**, in regards to the noted reference periods.

Perinatal Care Elective Delivery Measure (PC-01): 4Q2022 Discharges

Reference Period: October 1 – December 31, 2022

Instructions are available on the Knowledge Center. The [PC-01 Quarterly Submission Report](#) provides the data needed for data entry into the HQR Portal if this data is being abstracted in ENCOR Hospital Abstracted Measures.

Hospitals that do not deliver babies must enter a zero (0) for each of the PC-01 data entry fields prior to each quarterly submission deadline unless they submit an ECE (Extraordinary Circumstance Exception) form.

(Critical Access Hospitals are not required to enter PC-01 data since they do not participate in IPPS but may enter it if they wish to.)

Maternal Morbidity Structural Measure: 2022 Discharges

Reference Period: 01/01/2022 - 12/31/2022

Due Date: 4/01/2023 - 05/15/2023

PLEASE NOTE: Reporting of the Maternal Morbidity Structural Measure is mandatory for all hospitals.

Hospitals will respond to a two-part question:

“Does your hospital or health system participate in a Statewide and/or National Perinatal Quality Improvement Collaborative Program aimed at improving maternal outcomes during inpatient labor, delivery, and post-partum care, and has it implemented patient safety practices or bundles related to maternal morbidity to address complications, including, but not limited to, hemorrhage, severe hypertension/preeclampsia, or sepsis?”

- Hospitals will then choose from the following response options:

(A) Yes

(B) No

(C) N/A (our hospital does not provide inpatient labor/delivery care)

Hospitals will submit responses once a year via a CMS-approved web-based tool within the HQR Secure Portal.

Data Accuracy and Completeness Acknowledgement (DACA).

Reference Period: 01/01/2022 - 12/31/2022

Due Date: 4/01/2023 - 05/15/2023

The DACA is an annual requirement for providers participating in the Hospital IQR, IPFQR, and PCHQR Programs to electronically acknowledge that the data submitted to these programs by or on behalf of the providers are accurate and complete to the best of their knowledge.

Eligible IQR hospitals are required to complete the annual DACA using the Inpatient Web-Based Measures data collection tool, through the [Hospital Quality Reporting Secure Portal](#).

The following are OQR Measures Submitted Via a Web-Based Tool. The deadline for entering these via HQR Portal is **May 15, 2023**, in regard to the noted reference periods.

NOTE: This is optional for Critical Access Hospitals.

OP-22: Left Without Being Seen

Reference Period: 01/01/2022 - 12/31/2022

Submission Period: 01/01/2023 - 05/15/2023

For facilities that use our Rapid Application, there is a report to obtain this data located under the Miscellaneous Tab in Rapid. There is a note on the report if there is no Left Without Being Seen, Left Before Triage, Left Before Treatment Complete, Elopement or some other LWBS Discharge Disposition. Against Medical Advice is not the same as Left Without Being Seen and is not counted in the report. As with all CMS Quality measures, the facility is responsible for the accuracy of data entered into the portal.

OP-29: Appropriate Follow-Up Interval for Normal Colonoscopy in Average Risk Patients

Reference Period: 01/01/2022 - 12/31/2022

Submission Period: 01/01/2023 - 05/15/2023
